vagina, skin to skin. [REDACTED] said while the suspect rubbed her vagina he inserted his finger into her vagina. [REDACTED] said while this was occurring she continued to ask the suspect to stop; however, he would tighten his arm around her neck and tell her not to scream or he would shoot her. [REDACTED] said while her pants and underwear were down, the suspect removed his pants and she could feel his penis rubbing on her buttocks. [REDACTED] said the suspect then attempted to insert his penis into her vagina; however, he was not able to. [REDACTED] said the suspect's penis did not feel "Hard" and this is possibly why he was not able to insert his penis into her vagina. [REDACTED] said the suspect suddenly stopped and she was able to pull up her shorts and underwear.

bill, and exited her residence and gave it to the suspect. [REDACTED] said after she gave the suspect the money he quickly walked away northbound on the east sidewalk of [REDACTED] and she ran to her residence and advised [REDACTED] of what had just occurred.

[REDACTED] said she could identify the suspect if seen again. [REDACTED] said she believes the entire incident lasted 10-15 minutes. [REDACTED] said she believes the sexual assault lasted about eight minutes.

I contacted [REDACTED] who said she was inside her residence when [REDACTED] arrived. [REDACTED] said [REDACTED] was visibly distraught and was crying. [REDACTED] said she asked [REDACTED] what was wrong and [REDACTED] only replied, "Mom just give me a minute please." [REDACTED] said [REDACTED] grabbed money from inside the residence and walked outside. [REDACTED] said she followed [REDACTED] outside and observed [REDACTED] approach the suspect who was standing on the east sidewalk about two residences north of her residence.
